#### January 2023

#### Saints of Zion,

We praise God for another year of ministry and growth here this mission field we have been given. In a world that faces numerous challenges and massive change, we continue to do the ministry of Jesus while being changed and challenged ourselves. Thankfully, we seem to be up to the task! While some transformations and changes have been natural and easy, others are difficult. Nevertheless, here we are!

We continue to learn that while the Word of God is steady and the resurrection of Jesus is the same, and the living into it as a Lutheran congregation in the United States is not. Zion, like every other congregation, Lutheran or not, has in some ways needed to reinvent ministry. #### FINANCIAL SECRETARY ANNUAL REPORT-2022

For each deposit I balanced the counters' total with all contributions and other sources of income. Online deposits were verified and contributions were recorded for each source monthly. In January 2022, I distributed annual giving statements for 2021 and in October 9-month reports for 2022.

Announcements regarding voting (active) member status have been given at worship services, published in Zion emails, and provided with envelope boxes. It is important that EACH YEAR every confirmed member of Zion makes a contribution of record (i.e. using assigned numbered envelopes, name on another envelope, or electronically) AND fills out a communion card (green card or online) when receiving the sacrament. Every year Zion submits counts to the ELCA and they should be accurate and as high as possible. Your cooperation in this is appreciated, especially for younger confirmed members.

**Budget** categories for donors include general budget, special envelopes, and initial envelope. Giving units are comprised of members and friends who received envelope boxes plus members without boxes who donated (including online). \$239,085 were contributed towards those Budget categories by 100 donor units giving an average of \$45.98/week, compared to 107 units that gave an average \$43.65/week in 2021.

**Building** mortgage payments for roof, parking lot, & amp; tuck-pointing done before 2011 were moved into the 2021 budget, but I have still kept track of how much money was earmarked for Building since then. \$9966 were donated to more than cover the \$8004 paid.

Online giving through Vanco has continued, but less than 2021, and Venmo has been introduced in Dec. Combined electronic giving for 2022 totaled \$126,385 less cost of \$2344, some of which was offset. About 48% of total giving by the 100 units was done online.

Building Use income of \$25,820 was even more substantial with more groups using our facilities the whole year.

A significant source of income was from Thrivent Choice Dollars. Nineteen Zion members and friends directed \$2484 to Zion's budget, down from \$4052 by 19 Thrivent members in 2021.

Our thankful response for God's many blessings in our lives is to give back to Him a share of our time, talent, and treasure. THANKS to all who gave generously to Zion's ministry in 2022. We have spread God's love here in Ferndale, SE Michigan, nationally, and globally.

#### FINANCE TEAM ANNUAL REPORT - 2022

As the Corona Virus pandemic continued, we remained hopeful that our beloved congregation would still be able to give to God and our mission. Luckily, no major projects were required for us to raise funds for, so we could focus on our general budget.

The Finance Team brought back the holiday Scrip gift card sales in November and December and generated \$11,975 in sales that brought \$477 in profit to Zion.

We have also created a Venmo account to accept donations in hopes people will have more options to give beyond our app and website.

With the help of Dagmar Jones and Sandy Ayers, the Finance Team monitored our giving and finances throughout the year and no big asks or pushes were needed. With the increased building rental income and a couple of large gifts, we were able to stay on track in 2022.

We are happy to report that our church family gave a collective \$271,497 to the General budget that we had set at \$288,724. Thankfully, our budget expenses stayed below this giving at \$264,532. See the treasurer's report for full details. Total church income, including non-budget came to \$304,754. This gave us a nice \$9,111 cushion for overall income versus expenses. Looking ahead to 2023, we have advised Council to approve and send to the congregation a budget that includes a 5% increase over last year. We pray that our church family can fulfil this request since we fell short of our budget income last year and will give quarterly updates to the congregation with our progress and hope for our expenses to be less than expected like last year.

Are you not sure how much you should be giving to Zion to support our mission? While everyone's ability to give is different, we hope this handy chart on the following page can give you a guide to your income and what percentage is calculated that you give to the church.

#### ZION FOOD PANTRY ANNUAL REPORT - 2022

Zion's Food Pantry was rebooted this year. Since the food pantry is staffed by volunteers, the work was divided into Administration, Operations, and Distribution to spread the work load more evenly. We all work together for the success of the pantry. Carol Wunderlich handles the Administration which includes registration of guests and filing the required paperwork with Gleaners and The Emergency Food Assistance Program (TEFAP).

Ruth Steinert is our Operations Manager. She orders the food from Gleaners, prepares the list of foods to be packed in bags and the shopping list for guests, and performs the inventory each month. More on the shopping list later. She also manages the new email address for the pantry.

Jackie Oliver is the Distribution manager, organizes the volunteers and the distribution of food, acquires the fresh and frozen produce and butter, makes sure the guests receive all the food and other items available, and ensures everything is carried to their vehicles.

The food pantry is focused on helping our guests receive the food that they and their families want and will consume. We give them the option of receiving two prepacked bags of food or selecting the food they want and need from a "shopping list." Giving guests the option to "shop" allows them to select items that best meet their needs.

The pantry has a new email address, zionlutheranfoodpantry@gmail.com where our guests can preorder their bags of food from the shopping list and pick them up on the third Wednesday of the month. The guests can also order from the shopping list on the day of distribution and have their order filled while they shop at the tables of supplies. This option grows more popular each month.

Everyone gets the opportunity to select spices, condiments, cleaning supplies (hand soap, dish soap, laundry detergent, shampoo, body wash, hand sanitizer, multipurpose cleaner), bathroom tissue, paper towels, fresh produce (potatoes, carrots, onions, apples, and mandarin oranges), frozen vegetables, butter, and other items. Our guests say it is fun to come to our pantry and shop.

In March, June, September, and December, the pantry receives food from The Emergency Food Assistance Program (TEFAP). In those months, our guests receive an additional one or two bags of food depending on what we receive.

We have distributed approximately 6,570 pounds of food this year, serving over 755 individuals. We also provided numerous individuals with emergency food bags throughout the year. We could not do any of this without the support of the congregation. Thank you to everyone who contributes to the pantry. We want to thank Pastor Bode and Stephanie Melnick for their support during the rebooting and Stacey Jamison for her technology assistance. We want to thank Delando Perkins, our custodian, for all he does in support of the pantry.

We were very blessed to receive generous food donations from two of our local businesses, Common Citizen and Second Story Collection. As in the past, we have received monetary donations in the form of a gift card from Meijer and a generous check from the CROP walk. We thank Hollywood Market where we purchase our grocery bags. A huge thank you goes to our partner affiliate Gleaners Community Food Bank. We are very fortunate to be able to purchase a large portion of our food, paper products and cleaning supplies from Gleaners at a great cost savings.

We want to thank our volunteers. They work hard to get everything organized, ready for delivery, and distributed. #### **ZION JUNIORS ANNUAL REPORT - 2022**

There has been so much going on in the world of Zion Juniors, especially now that we are together in person again! Zion Juniors is the community of children in our church ranging from birth to middle school. There are several branches of this community, all of which are now active.

**Zion Juniors** - As a community, we have done gatherings and outings, and plan to do more. We are planning a movie/activity night this winter, and have an annual Labor Day camping trip. We encourage our grade school children to attend Living Water Ministries summer camp each year. This year we will attend June 18-23. Juniors are starting to take on bigger responsibility in the greater church community, such as cross bearing. We communicate and plan as a group regularly through our Facebook group.

**Zion Sprouts** - This is a community for babies through age 4 and their adults that meet once a month before church. Sprouts experience an introduction to God through music, stories, movement, etc. Sprouts restarted for the first time this January since the pandemic hit.

**Zion Juniors Explore** - This is our Sunday education program for our children ages 4-5 through middle school. This happens most Sundays during worship, excluding holidays, school breaks, and the summer. Ideally we would run two classes regularly, one for the younger students, and one geared toward older students who are ready for a more in depth conversation in preparation for confirmation. Currently, we are struggling to staff one class each week, so we are unable to have two classes on a regular basis. We are looking for more volunteers to teach Sunday classes.

**Zion Juniors Music** - Music restarted in full capacity this fall. In December, these children presented their annual Christmas program. We are currently planning to present something during church about every six weeks. The children are learning to play hand chimes and will also get experience with our African drums soon.

#### **ACTIVE CHRISTIAN TEENS ANNUAL REPORT - 2022**

ACT started the year with some bad news, that the ELCA National Gathering, already postponed because of COVID-19, would be cancelled until the next year in the rotation, 2024. That meant a generation of our youth would not have access to the Gathering. Brainstorming needed to be done.

Leader Katie Brisson and Pastor Matthew Bode gathered the youth for a series of evening, usually around cooking, in the church kitchen to build relationship among our small group. Numerous conversations about what life is like for them in COVID, what God is doing in their lives, and what we wanted to do as a group happened.

We decided to do a justice and vocation trip to Chicago in July of 2022. Our band of two adults and three ACTs got on the Amtrack for a 4 day tour of the city. We focused on God's call and exploring urban areas that may be new to us. Among the many things we did was tour a local Chicago neighborhood with youth from that neighborhood and visit local museums dedicated to local art. We ate at authentic ethnic-specific restaurants in neighborhoods that reflected those ethnicities, took public transit the entire time we were there, and did our best to talk to local residents about life, sharing and learning. In addition, we visited the Lutheran School of Theology at Chicago where we had an extensive conversation with a staff member and student

about call and vocation.

Overall, we believe this was a fantastic trip with deep reflection and fun in a small group that allowed for easy travel and discernment. This may be another model for youth trips in the future. We thank the congregation for all of the prayers and financial support that made the trip possible. If you are able to give to ACT, we know that it would be helpful for future trips for the next line of youth. The next ELCA Youth Gathering is scheduled for the summer of 2024.

#### SOCIAL MINISTRY ACTIVITIES - 2022

In 2022 group activities and those centered at the building were gradually reactivated, without a formal umbrella committee. Thanks to the many people involved in showing God's love within and beyond our walls.

- Cards were sent regularly to shut-ins and other ill people on the prayer list, as well as birthday cards to the congregation.
- Food Pantry packing and distribution was shared by many people who worked to provide food to families once a month, in partnership with Gleaners.
- Food Pantry made special Thanksgiving "baskets" in Nov. to assist families with a turkey and other traditional meal items.
- In Sept. the CWS/Crop Walk in Ferndale was a combined in-person and virtual event, in conjunction with 6 other churches in Ferndale (St. Luke's Episcopal, First United Methodist
- Our Mother of Perpetual Help RC) and Royal Oak (First Congregational, First Presbyterian, Good Shepherd/ Prince of Glory/ Trinity Lutheran this year. Total Zion donations of \$5000 supported 21 Zion actual, virtual, and spirit walkers. Zion's Food Pantry received \$1305 (8.3% of total Ferndale & amp; Royal Oak donations (over \$15000) with 3 food pantries sharing local funds). Now that our \$5000 challenge has been met, we're waiting to hear Pastor Bode play his trombone.
- Our contributions to Lutheran World Relief were 1 Personal Care Kit, 2 Baby Care Kits, and 50 School Kits -- all delivered and loaded into trucks in October to go to the Baltimore warehouse.
- Detroit Rescue Mission Ministries (DRMM) was the recipient of many coats, sweaters, toiletries, and bedding throughout the year.
- On a personal level, individuals prepared meals, visited, and provided home/personal assistance to members who had short or long term needs.
- Secret Pal program continued, which involves cards, little gifts, and special-day remembrances secretly given to a "Pal" throughout the year, until identities are finally revealed at Easter. This program promotes connections and involvements between congregants of all ages.
- Prayer Shawl participants have knitted/crocheted many shawls and blankets to comfort people in hospitals and at home. Meetings have resumed in 2022 to foster community to the group.

Newcomers are always welcome to this fulfilling ministry.

- Close-to-expiration breads from Costco are occasionally available to the community.
- Zion honored a budget commitment for support to Samaritas, the Michigan ELCA social ministry organization. We also collected money through a special envelope category for Synod's Detroit mission efforts.

#### PRAYER SHAWL MINISTRY ANNUAL REPORT - 2022

Since its inception in October, 2007, members of Zion's Prayer Shawl Ministry prayerfully knit and crochet shawls, lap robes, and baby blankets.

Members craft these items at home and meet as a group once a month September-May in Zion's Lounge.

Following a prayer of blessing, over the years hundreds of these items have been gifted out to individuals, hospitals, nursing homes, or where there is a need.

Financially we are not a budgeted item, but continue to be self-supporting. We welcome donations of yarn for the ministry's use, which many times can be found at garage sales, estate sales, or resale shops.

We welcome new members to the ministry.

#### WOMEN OF ZION ANNUAL REPORT - 2022

In 2022 Women of Zion (Women of the ELCA, W/ELCA) has supported various projects and ministries. Specific services were not held, but funds were raised for causes by envelopes in offering boxes, announcements in worship, and emails.

Rachel's Day, usually observed in May, focused on raising donations to be forwarded to churchwide W/ELCA for women and children in crisis situations. This year donations were \$345 (up from \$216 in 2021).

Donations for Thankoffering totaled \$190 (up from \$185 in 2021) in the fall to be sent to the churchwide W/ELCA to support its national programs and provide resources to local units. One funeral luncheon was provided in 2022 for Fred Reed, former custodian at Zion, who is sorely missed in Zion's kitchen.

Women are encouraged to make use of personal W/ELCA resources on the website womenoftheelca.org. Local Bible study and discussion has continued on Zoom in 2022, using materials from the national magazine "Gather", which is available at church for reading. Additional participants are welcome on the 1st & 3rd Thursdays of the month at 11:00. Join via the midweek Hope service link. Thanks to Mur Hucul for leading these sessions and mastering Zoom.

Thank you to the congregation for contributing to the Women's Annual Ingathering Fund (WAIF) envelope in February and other donations. That income presently supports magazine subscriptions and funeral luncheons as needed, with a tithe of WAIF sent to the SE MI Synod W/ELCA.

#### **2023 BUDGET PREVIEW**

The 2023 Zion budget is relatively close to the 2022 budget. However, there are a few changes. First, we have increased our planned benevolence giving to the synod. We give as a percentage of what we receive as a model for the congregation.

Altar guild has a significant budget increase due to the new costs of our communion elements. We did also allow for increases to utilities, as well as accounting/banking fees. You will see that we had a line item for Vanco usage fees, but we did not have a line item for other banking fees that we previously placed in miscellaneous. The new category places all of those fees in one place. We also decreased our line item for the Building Fund, in which we are paying back the Elijah Fund (ourselves) for a previous loan for building work. Another loan was paid off so that is reflected in the decrease.

Finally, the executive team took under consideration the pay rates of our staff. Some of our staff are considerably underpaid when comparing their positions to others in the same field. Therefore, we did some increasing to bring positions closer to those rates in their respective field. The executive team wants to make sure that staff are appreciated and are given a just wage.

We continue to be as faithful as we can with the resources that God has given us. Thank you for your giving that helps us move this ministry along.
